The GS1 Malaysia Databank Mobile App is a mobile application built based on cloud data access technology and leveraging on the **GS1 Malaysia Member Product Databank**. The Mobile App will enable access to product information and its brand owner information by just scanning the GS1 barcode on the product.

The purpose of this app is to provide **trusted and genuine product information** to the consumer with the accurate information submitted by the brand owner of the product. This will provide more visibility and authentication of any product scanned.



## Getting Started

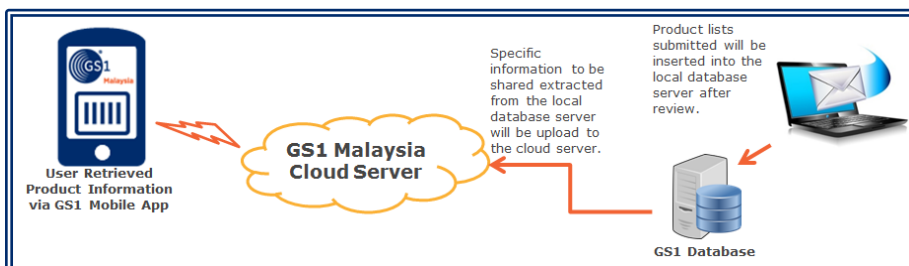
Has your company submitted a complete list of products to be registered with the **GS1 Malaysia Member Product Databank**?

GS1 Malaysia strives to help you ensure that your brand complies with current retailer requirements by listing all your products with the **GS1 Malaysia Member Product Databank**.



## Avoid Costly Mistakes

In 2016, GS1 Malaysia received a call from a member claiming that they are being sued for a product that doesn't belong to them but is carrying their barcode number.

With their complete listing of products registered and well-maintained in the GS1 Malaysia Member Product Databank, GS1 Malaysia was able to validate that the product in question does not actually belong to the company and the barcode number had in fact, been used illegally.

Check that your products have been registered with the **GS1 Malaysia Member Product Databank** by downloading the **GS1 Malaysia Databank Mobile App** and start scanning your products immediately!
